I understand and agree to abide by the following school policies for Before & After Care:

1. **PROGRAM COST:** The Before and After Care Annual Contract provides a discounted rate off the drop-in fee. The cost of the program is an annual cost which will be paid in equal payments over 10-months (August -May). Before and After Care fees will be invoiced along with tuition payments for primary students. Payments will be due on the 1st of the month, with first payment due **August 1, 2019**.
2. **ACCOUNTS PAST DUE:** If any account is more than 1 month past due, the child will be unable to participate in the before and after care program.
3. **LATE PICK-UP FEE:** After Care ends at 5:30pm. After a 5 minute grace period, there is a \$1/minute charge until child is picked up. This fee is charged REGARDLESS of reason for late pick up.
4. **HOLIDAYS/IN-SERVICE DAYS/ABSENCES:** No credit will be given for holidays and professional development and in-service days. These days have already been factored into the cost structure. No credits will be given for student absences due to illness, vacation, or closure due to emergencies or inclement weather.
